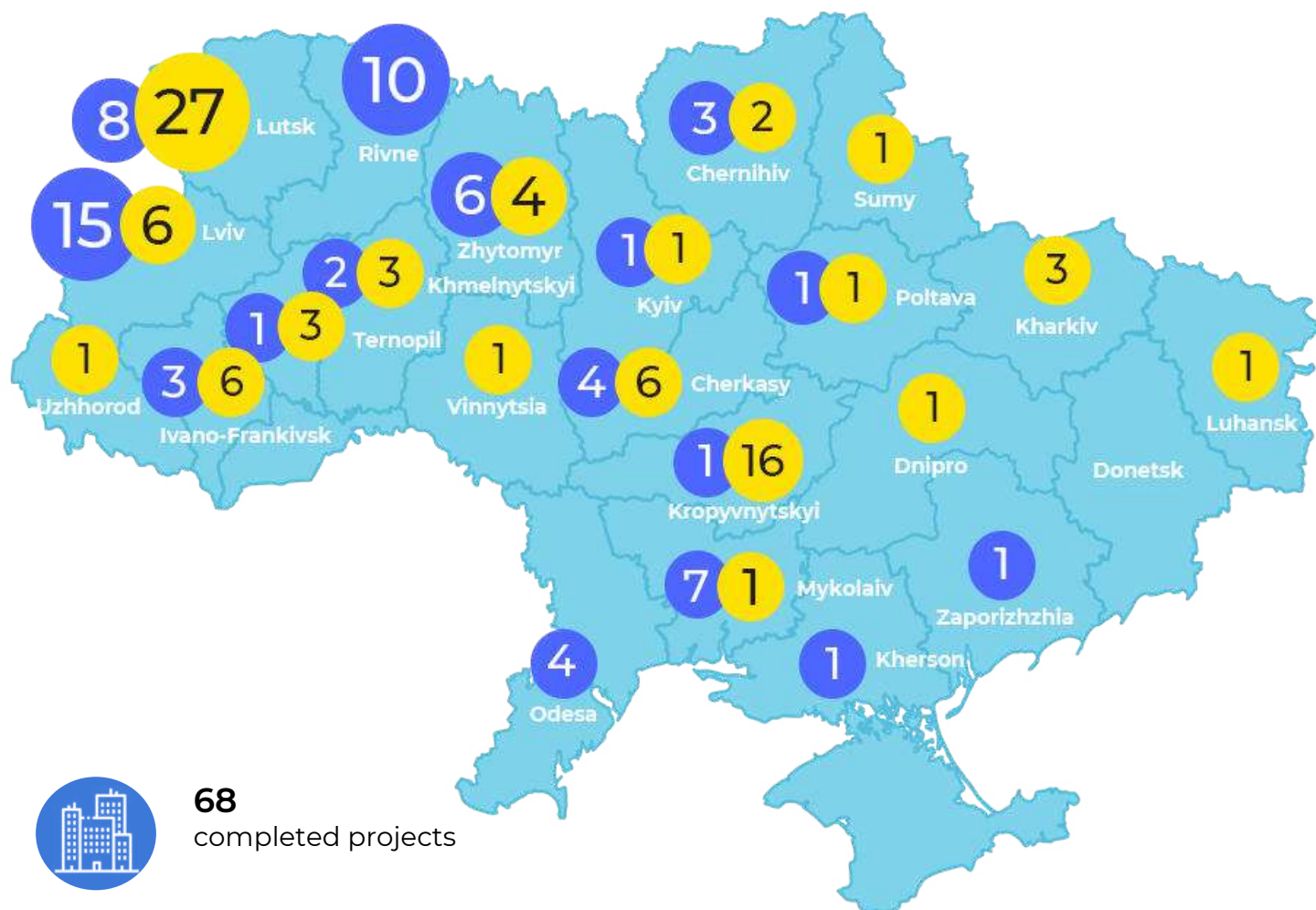

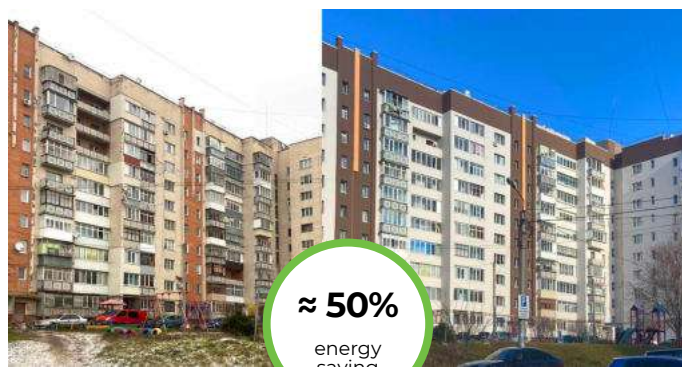

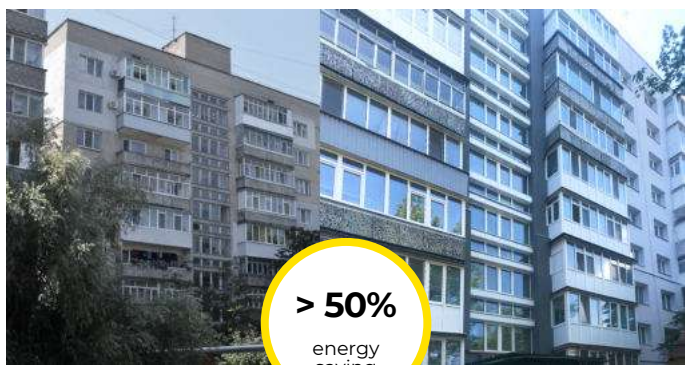

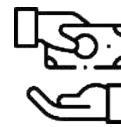

The organizational structure of the Energy Efficiency Fund has been optimized.

Taking into account the economic downturn in the country caused by the military actions of the Russia Federation, the Energy Efficiency Fund, as well as other state institutions, has optimized the number of employees. The relevant decision was initiated by the Directorate and adopted by the Supervisory Board of the Fund; the changes were introduced in effect on July 1.

The President of Ukraine has signed the Law, which provides for simplification for energy modernization of buildings and expands the scope of activities of the Energy Efficiency Fund.

On July 9, the Verkhovna Rada of Ukraine adopted in the second reading and in general the document on creating conditions for the introduction of comprehensive thermal modernization of buildings (the Draft Law No. 6485). It provides for amendments to the Law of Ukraine "On Energy Efficiency Fund". On August 1, President of Ukraine signed the Law "On Amendments to Certain Laws of Ukraine on Creating Conditions for the Introduction of Comprehensive Thermal Modernization of Buildings".

On November 30, it was a presentation of the "VidnovyDIM" Program that was designed to support finance the restoration of residential buildings damaged as a result of the military aggression of the Russian Federation against Ukraine. The pilot phase of the Program, for which the European Union has currently allocated EUR 5 million, is being implemented by the Energy Efficiency Fund in cooperation with the International Finance Corporation (IFC).

The Government has introduced amendments to the Cabinet of Ministers of Ukraine Resolution No. 590, which allow the State Treasury Service to restore financing of the Energy Efficiency Fund's expenditures under martial law.

This became possible due to the adoption of the Resolution of the Cabinet of Ministers of Ukraine "On Amendments to the Procedure of Execution of Powers by the State Treasury Service in a Special Regime Under Martial Law".
